The Regular Meeting of the Apple Creek Council called to order on March 18, 2019 by Mayor Rodney Mackey with the following council members answering to roll call:

Councilman Conrad made a motion to approve the minutes of the March 4, 2019 meetings, as always, they are available for the public to review. The motion was seconded by Councilman Lewis. VISITORS: Kathy Mitchell was present over the lot the Village owns at 12 W. Main St. Mayor Mackey reported the road is slanted 3 inches. He stated he did see watering running down to the parking lot and not jumping the catch basins. The water is coming from the slant of the road. He did not see the water running into the wall. Kathy stated you don't need to see it running, there is erosion. Mayor stated that could many things causing that, but he can see water running to the corner of the house. The Village's first preference to raise the alley and get the water running the correct way. Kathy reported they would like to put three parking spaces in the back, should have two on High St. and parking on St. Rt. 250. With our solicitor not being at the meeting we could not answer about the letter he was to send to the land owner of the adjacent property. If we can get the water running down the alley and the guy to fix his property Kathy would like to offer the Village \$8,000 for the property. The property was never surveyed when the Village bought it. If Kathy wants it survey, she will have to do it.

Also present was Kevin Dean of Dean's Backflow. He was present to explain the issues we have been having with the pumps at the lift station and main sewer plant. Lately the problem has been with the pumps at the lift station. Two of the three pumps have been repaired numerous times. Right now, two pumps have been fixed and the third one is still in the pit. The main issue is that the pumps were not programed right when we did the upgrade. Kevin has them working now, but the problem is in the software and the person who works on them is not well. Kevin is going to contact another person he knows and see if he can look at the system and fix it. Also, Kevin has been given permission to remove the third pump from the pit and have it checked out.
