STREETS AND MAINTENANCE: Betty, Rodney, & Dale attended the ODOT meeting for St. Rt. 250 paving project. Update from the meeting they are planning to start the project soon. The group met Blackhorse Construction personnel at the ODOT meeting and have asked them to provide a quote for Apple Creek's catch basin repair. They will already be in Apple Creek to do repair work on the bridge down by the street garage. Mayor Keener reported we have a quote from Blackhorse Bridge Construction and Dirt Dawg to repair some of the storm sewer catch basins. Blackhorse Bridge Construction is the cheaper of the two. Blackhorse quote was \$46.650.00, this is repair or replace catch basins on St. Rt. 250 prior to the ODOT paving project. The village will ask for \$30,000 from the Permissive Tax Fund and \$16,650 from the State Highway Fund. Councilperson Stoffer inquired what the quote from Dirt Dawg was and the Mayor replied over \$63,000.

Mayor Keener also wanted to update us on the grant for the sidewalk project. She feels we have a pretty good chance of getting the grant. Mayor Keener met with Scott Wigman today. He was asked to verbally support our grant to ODOT. Scott and the Mayor went down to the bridge to review how small the berm is on the bridge. He was amazed how narrow it was. He is more than happy to support the Village. Councilperson Harwood reported he ran into Scott at the airport. Mayor reported that she and Scott also went over today and looked at the drainage problem. Scott stated there is no funding for a couple years. Our budget is done and there is no money available. We cannot go on the property and do anything until we get permission from the owner. Get a plan of action together and can apply for a grant, Betty has a list of grants that are available.

If we would get sued we would have to hire a California lawyer. No one at Engineering and Associates knows water & sewer. Jeff feels with an hourly rate we probably won't have a problem, it would be if we have a big project. Rodney Mackey made a motion to hire Aecon for engineering for the Village at a price of \$130.00 per hour as an as needed basis. This motion was seconded by Councilperson Conrad. Roll call was as follows: Council President Mackey-yes, Councilperson Conrad-yes, Councilperson Harwood-yes, Councilperson McCarthy-yes, Councilperson Lewis-yes, and Councilperson Stoffer-yes.

After Mayor Keener gets back from vacation we will be reviewing the employee handbook. Our handbook has not been updated in years.

NEW BUSINESS: Councilperson Stoffer brought up the cat issue and the unlicensed cars in the Village. He would like to see the policemen doing something about this. release them on Monday. He refused to let them do it. The police department are doing citations and turning them into the Prosecutor, it is up to him to proceed.
