

The Regular Meeting of the Apple Creek Council called to order on October 15, 2018 by Mayor Rodney Mackey with the following council members answering to roll call:

Rick Conrad-present, Mike Harwood-present, Robert McCarthy-absent, Charlie Lewis-present, and Steve Stoffer-present.

Councilman Conrad made a motion to approve the minutes of the October 1, 2018 meetings, as always, they are available for the public to review. The motion was seconded by Councilman Harwood. Roll call was as follows: Councilman Conrad-yes, Councilman Harwood-yes, Councilman Lewis-yes, and Councilman Stoffer-yes.


