ADDITIONALLY, THE APPLICANT(S) ALSO: (1) AGREE TO ABIDE BY ALL TERMS AND CONDITIONS AS DESCRIBED IN THE CUSTOMER DEPOSIT POLICY; (2) GRANT PERMISSION TO THE UTILITY DEPARTMENT TO SEEK APPROPRIATE INFORMATION FROM THE ABOVE NAMED INDIVIDUAL(S) AND EMPLOYER(S); AND (3) AGREE TO ABIDE BY ALL RULES AND REGULATIONS OF THE UTILITY DEPARTMENT, INCLUDING THOSE WHICH STATE THAT THE AGENTS OF THE UTILITIES SHALL HAVE FREE ACCESS TO THE WATER METERS AND CONNECTIONS AT ANY TIME.
