POLICE: Chief Woodruff gave council the monthly report; the numbers are about the same; there has been one application for part-time; Swysgood thanked the police for the help with the traffic control for the street work.

STREETS AND MAINTENANCE: Scab patch – (4) Holes temporary; Melway will come back in the spring to do a more permanent repair; door hanger for leaves & grass being put in the street; they will be running back and forth to pick up leaves instead of just doing Tuesday and Thursday; 5 trees were removed; Chief Woodruff is working on an app to notify residents about what is going on in the village.

WATER & SEWER: The Dogwood storm sewer was repaired after a company hit it; continuing documentations to EPA as they are requiring one for wastewater also; D & L Drain will be TVing the sewer line from the Golden Bear to High St. and then will be coming back in to clean it out where it is needed; Campbell Oil has changed their mind on the sewer connection which will be on Main instead of Mill.
